Terms of Use

By signing this agreement, the user and/or his/her contracting authority agrees that when using the archival collections of the Vienna Wiesenthal Institute (VWI), the Documentation Centre of the Association of Jewish Victims of the Nazi Regime (BJVN) and the Israelitische Kultusgemeinde Wien (IKG) he/she will respect all applicable copyright and data protection laws as well as other interests of third parties that are worthy of protection and that he/she will obey all legal requirements regarding civil status, data protection, and archival regulations (as stipulated by the Austrian Federal Archive Law) in their currently valid forms.

Personal data such as names, addresses, and other information that could enable the identification of people worthy of protection according to data protection laws may not be made public. Where applicable, references to individuals must be anonymised.

(Regulations for personal data in archival collections: The individual was either born at least 110 years ago, is demonstrably deceased, or the user has written permission from the family to publish their personal data). A shortening of the period of protection may be applied for in order to review materials.

The user agrees to protect the archive of the Vienna Wiesenthal Institute from any claims or damages by third parties that may arise as a result of the use of the archival collections. The user is solely responsible in case of violations of personal data, data protection, copyright, and personality right laws.

The user agrees to cite the appropriate signatures as references with every use of the archive's materials.

The user agrees to submit to the archive, unprompted and without charge, two copies of every publication immediately upon publication for which archival materials were used.

Archival materials may not be loaned out.

The user agrees to store securely any copies/scans/photographs of archival materials and to protect them from access by unauthorised third parties. Copies/scans/photographs may not be used for any purpose except the purposes indicated on this form. The use of archival materials for commercial purposes or the use/transfer of copies/scans/photographs (whether in whole or in part) of archival materials by or to third parties is not allowed.

The partial or total reproduction of archival materials in publications (printed works, exhibitions, film and TV, online media etc.) is only allowed with special permission from the archive. *Please request the appropriate form from the archive.*
